## AN ORDINANCE AMENDING ORDINANCE 141: REGARDING DISORDERLY CONDUCT

The Village Board of the Village of Dorchester does hereby ordain as follows:

Ordinance 141, Section 1 is amended as follows:

## Section 1.

- a. DISORDERLY CONDUCT. No person shall in a public or private place, engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct under circumstances in which such conduct tends to cause or provoke a disturbance.
- b. HARASSING OR OBSCENE PHONE OR ELECTRONIC COMMUNICATIONS. No person shall place or send any phone or electronic communication which does any of the following:
  - 1) Makes any comment, request, suggestion or proposal which is obscene, lewd, lascivious, filthy or indecent;
  - 2) Makes a telephone call or sends an electronic communication, whether or not conversation ensues, with the intent to abuse, threaten or harass any person on the other end of the communication;
  - 3) Makes or causes the telephone of another repeatedly or continuously to ring, with intent to harass any person at the called number or numbers;
  - 4) Makes or sends repeated telephone calls or electronic communications, during which conversation ensues, solely to harass any person at the other end of the communication;
  - 5) Knowingly permits any telephone or electronic device under his/her control to be used for any purpose prohibited by this section;
  - 6) In conspiracy or concerted action with other persons, makes repeated or simultaneous calls or sends repeated or simultaneous electronic communications solely to harass any person at the other end of the communication.

c. DISORDERLY CONDUCT WITH A MOTOR VEHICLE. No person shall, within the Village of Dorchester, on public or private property, by or through the use of a motor vehicle, motorcycle, snowmobile or mini-bike, under circumstances which tend to cause or provoke a disturbance, engage in violent, abusive, unreasonably loud or otherwise disorderly conduct, including but not limited to unnecessary or deliberate or intentional: spinning of wheels, squealing of tires; revving of the engine; blowing the horn(s); causing the engine to backfire; or causing the vehicle, while commencing to move or in motion, to raise one or more of its wheels off the ground. Such conduct is declared to be both unlawful and a nuisance.

Passed at a regular session of the Village Board this 1st day of May, 2019.

This ordinance shall be effective upon publication.
