The Village of Dorchester, does ordain as follows:

Section 1. No person shall kindle or maintain any bonfire or rubbish fire or authorize any such fire to be kindled or maintained on or in any public street, alley, road or other public ground without a permit from the fire department, During construction or demolition of buildings or structures no waste materials or rubbish shall be disposed of by burning on the premises or in the immediate vicinity without having obtained a permit from the fire department.

Section 2. No person shall kindle or maintain any open fire or authorize any such fire to be kindled or maintained on any private land without first having obtained a permit from the fire department. Nor shall any fire be kindled or maintained in any outdoor container unless such container has been approved by and a permit issued by the fire department. The burning of garbage or refuse that smolders or gives off noxious odors is prohibited.

Section 3. The chief of the fire department may prohibit any and all bonfires and outdoor rubbish fires when atmospheric conditions or local circumstances make such fires hazardous.

Section 4. Any person, firm or corporation violating any pro-
vision of this ordinance shall be fined not less than
Dollars (\$ 100.00) and a
separate offense shall be deemed committed on each day during or
on which a violation occurs or continues.

This ordinance shall take effect upon passage and publication. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 1. No person shall kindle or maintain any bonfire or rubbish fire or authorize any such fire to be kindled or maintained on or in any public street, alley, road, or other public ground without a permit from the fire department, During construction or demolition of buildings or structures no waste materials or rubbish shall be disposed of by burning on the premises or in the immediate vicinity without having obtained a permit from the fire department.

Section 2. No person shall kindle or maintain any open fire or authorize any such fire to be kindled or maintained on any private land without first having obtained a permit from the fire department. Nor shall any fire be kindled or maintained in any outdoor container unless such container has been approved by and a permit issued by the fire department. The burning of garbage or refuse that smolders or gives off noxious odors is prohibited.

Section 3. The chief of the fire department may prohibit any and all bonfires and outdoor rubbish fires when atmospheric conditions or local circumstances make such fires hazardous.

Section 4. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than \$10.00 Dollars nor more than \$120.00 Dollars and a separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

This ordinance shall take affect upon passage and publication. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
