**AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF MAYVILLE,
CLARK COUNTY, WISCONSIN, TO THE VILLAGE OF DORCHESTER, WISCONSIN.**

BE IT, HEREBY, ORDAINED, by the Village Board of the Village of Dorchester,
Clark County, Wisconsin, as follows:

Section 1. In accordance with Section 66.021, of the Wisconsin Statutes, and based upon a Petition for Direct Annexation filed with the Village Clerk, signed by the owners of all of the real property in the area within the territory to be annexed and all of the electors residing within the area petitioned for annexation, the following-described territory in the Town of Mayville, Clark County, Wisconsin, is hereby annexed to the Village of Dorchester, Wisconsin:

A parcel of land being part of the Southwest One-quarter of the Southeast One-quarter of Section Twelve (12), Township Twenty-nine (29) North, Range One (1) East, now in the Town of Mayville, Clark County, Wisconsin, to be annexed to the Village of Dorchester, described as follows:

Commencing at the South one-quarter corner of said Section Twelve, thence North along the West line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$ and the centerline of Liberty Avenue 726.00 feet; thence East 33.00 feet to the East right-of-way of Liberty Avenue and the point of beginning of this description: thence continue East 217.00 feet; thence North 325.00 feet; thence West 250.00 feet to the centerline of Liberty Avenue; thence South along said centerline 51.00 feet; thence East 33.00 feet to the East right-of-way of Liberty Avenue; thence South along said right-of-way 274.00 feet to the point of beginning.

Parcel contains 1.66 acres more or less.

Section 2. Attached to this ordinance, and made a part hereof, is a true and correct copy of a map prepared by E.T.C., Inc., of LaCrosse, Wisconsin, which represents the annexed territory.

Section 3. From and after the effective date of this ordinance, the territory described in Section 1 shall be part of the Village of Dorchester, Clark and Marathon counties, Wisconsin, for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules, and regulations governing the Village of Dorchester.

Section 4. All previous ordinances or parts of ordinances in conflict herewith are hereby repealed.


