VILLAGE OF DORCHESTER TRAFFIC ORDINANCE

The Village Board of the Village of Dorchester County of Clark, Wisconsin, Do Ordain as follows:

Section 1. PROVISIONS OF STATE LAW ADOPTED BY REFERENCE. STATE TRAFFIC FORFEITURE LAWS ADOPTED.

Except as otherwise specifically provided in this ordinance, all provisions of chapters 340 to 348 of the Wisconsin statues describing and defining regulations with respect to vehicles and traffic for which the penalty is a forfeiture only, including penalties to be imposed and procedure for prosecttion, are hereby adopted and by reference made a part of this ordinance as if fully set forth herein.
Any act required to be performed or prohibited by any statute incorporated herein by reference is required or prohibited by this ordinance.

Sectuib 2, PENALTY

The penalty for violation of any provision of this ordinance shall be a forfeiture as hereinafter provided together with the cost of prosecution imposed as provided in ss.345.20 to 345.53, Wis. Stats. UNIFORM OFFENSES. D Forfeitures for violation of any provision

of chs. 341 to 348 adopted by reference in section 1 of this ordinance shall conform to forfeitures for violation of the comparable state offence, including any variations or increases for second offenses.

Section 3. ENFORCEMENT.

This ordinance shall be enforced in accordance with the provisions of ss. 345.20 to 345.53 and ch. 299 of the Wisconsin Statutes.

Section 4. REFERENCES TO STATUTES.

References to specific statutory sections wherever used in this ordinanceshall mean the Wisconsin statutes of 1971. (Chapter 278, Laws of 1971).

Section 5. REPEAL OF CONFLICTING ORDINANCES.

All ordinances regulating traffic upon the streets, alleys, and highways of the County Village of Dorchester, and all ordinances or parts of ordinances heretofore enacted by the Village Board of the Village of Dorchester are hereby repealed.

Section 6. SEVERABILITY.

The provisions of this ordinance shall be deemed severable and it is expressly declared that the Board of Supervisors would have passed the other provisions of this ordince irrespective of whether or not one or other provisions may be declared invlaid invalid and if any provisions of this ordinance or the application thereof to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected thereby.

Section 7. EFFECTIVE DATE.

This ordinance shall take effect and be inforce from and after October 1, 1972 upon passage and publication as provided by law.

The Village Board of the Village of Dorchester County of Clark, Wisconsin, Do Ordain as follows;
