AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF MAYVILLE, CLARK COUNTY, WISCONSIN, TO THE VILLAGE OF DORCHESTER, WISCONSIN.

BE IT, HEREBY, ORDAINED, by the Village Board of the Village of Dorchester, Clark County, Wisconsin, as follows:

Section 1. In accordance with Section 66.021, of the Wisconsin Statutes, and based upon a Petition for Direct Annexation filed with the Village Clerk, signed by the owners of all of the real property in the area within the territory to be annexed and all of the electors residing within the area petitioned for annexation, the following-described territory in the Town of Mayville, Clark County, Wisconsin, is hereby annexed to the Village of Dorchester, Wisconsin:

The North 594 feet of the West 660 feet of the SW 1/4 - SE 1/4 except beginning 726 feet North of the SW corner, thence North 325 feet, thence East 250 feet, thence South 325 feet, thence West 250 feet, and except the West 33 feet;

The East one-half of the SW 1/4 - SE 1/4;

The West 165 feet of the SE 1/4 - SE 1/4;

The South 300 feet of the East 418 feet of the West 583 feet of the SE 1/4 - SE 1/4;

The South 60 feet of the West one-half of the SW 1/4 - SE 1/4;

All located in Section Twelve (12), Township Twenty-nine North (T. 29 N.), Range One East (R. 1 E.), now in the Town of Mayville, Clark County, Wisconsin.

Parcel contains 35 acres more or less.

Section 2. Attached to this ordinance, and made a part hereof, is a true and correct copy of a map prepared by E.T.C., Inc., of LaCrosse, Wisconsin, which represents the annexed territory.

Section 3. From and after the effective date of this ordinance, the territory described in Section 1 shall be part of the Village of Dorchester, Clark and Marathon counties, Wisconsin, for any and all purposes provided by law, and all persons coming or residing in such territory shall be subject to all ordinances, rules, and regulations governing the Village of Dorchester.

Section 4. All previous ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

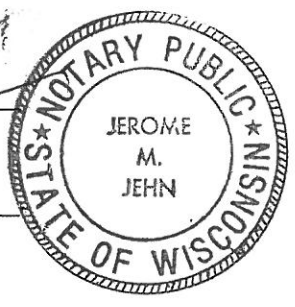
