

ORDINANCE 177

AN ORDINANCE PROVIDING FOR THE VILLAGE OF DORCHESTER TO ACT AS ITS OWN CONTRACTOR FOR THE PURPOSE OF PUBLIC CONSTRUCTION

The Village Board of the Village of Dorchester do ordain as follows:

SECTION 1. PURPOSE.

The Village Board, upon recommendations of the Street, Sewer and Water Committee have determined, pursuant to the authority granted to it under the provisions of Section 62.15, Wisconsin Statutes, that it would be in the public interest to have the Village employees undertake certain public construction for improvements to the Village, without submitting the same for bids.

SECTION 2. NATURE OF PUBLIC CONSTRUCTION.

Vircks Drive - extend water and sewer lines south 500 feet to 2nd Ave. East. Extend the roadbed of Vircks Drive 500 feet south to 2nd Avenue East.

Second Avenue East - install water and sewer lines west of Vircks Drive for approximately 1500 ft. to Parkside Drive.

Extend Second Avenue East roadbed 500 feet west of Vircks Drive.

SECTION 3. DIVISION OF COSTS BETWEEN THE VILLAGE OF DORCHESTER GENERAL FUND AND WATER DEPARTMENT.

The total cost of the project shall be ascertained and allocated as appropriate to the Village of Dorchester Water Department, Sewer Department and the Village of Dorchester Street Department and to the Village of Dorchester General Fund for general labor costs.

SECTION 4. LEVY OF SPECIAL ASSESSMENTS.

None of the other projects for which the Village will act as its own contractor require the levy of special assessments.

SECTION 5. SUPERVISION OF PROJECT.

The Village President and the Streets, Sidewalks and Lights Committee are authorized to negotiate contracts for material and labor at the lowest price available for contractors determined to be responsible to have general oversight for the construction work to be accomplished as a Village work project.

SECTION 6. ACCOUNTING.

Pursuant to the statutory requirements, the Village Clerk will keep an accurate account of the costs of the project. The cost shall include necessary overhead expenses, and upon completion of such work, the Village Clerk shall make a complete report thereof to the Village Board, stating in detail the items of costs and the total cost of doing such work for the project, and the Village Clerk shall publish

such report as part of the proceedings of the Village Board Meeting. The preparation of the report as provided by State Statute is hereby delegated to the Village Clerk.


SECTION 7. REPEAL OF CONFLICTING ORDINANCES.
