

AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF HOLTON, MARATHON COUNTY, WISCONSIN, TO THE VILLAGE OF DORCHESTER, WISCONSIN.

BE IT, HEREBY, ORDAINED, by the Village Board of the Village of Dorchester, Clark/Marathon Counties, Wisconsin, as follows:

Section 1. In accordance with Section 66.0217(2), of the Wisconsin Statutes; this ordinance deals with the annexation of lands owned by Edward O. Brecke, Jr. and which are located in Marathon County, Wisconsin:

A parcel of land located in the Fractional Northwest One Quarter (NW 1/4) of Section Eighteen (18) Township Twenty Nine North (T. 29 N.) Range Two East (R. 2 E.) Town of Holton, Marathon County, Wisconsin, and described as follows:

The North 507.5 feet of the West 514.75 feet.

Exception to warranties: Streets, right-of-ways, ordinances, reservations, restrictions, exceptions, conditions, covenants, and easements, if any, of record. Parcel is 6.0 acres more or less.

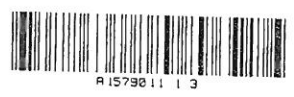
Section 2. Attached to this ordinance and made a part hereof, is a true and correct copy of a map which represents the annexed territory.

Section 4. All previous ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

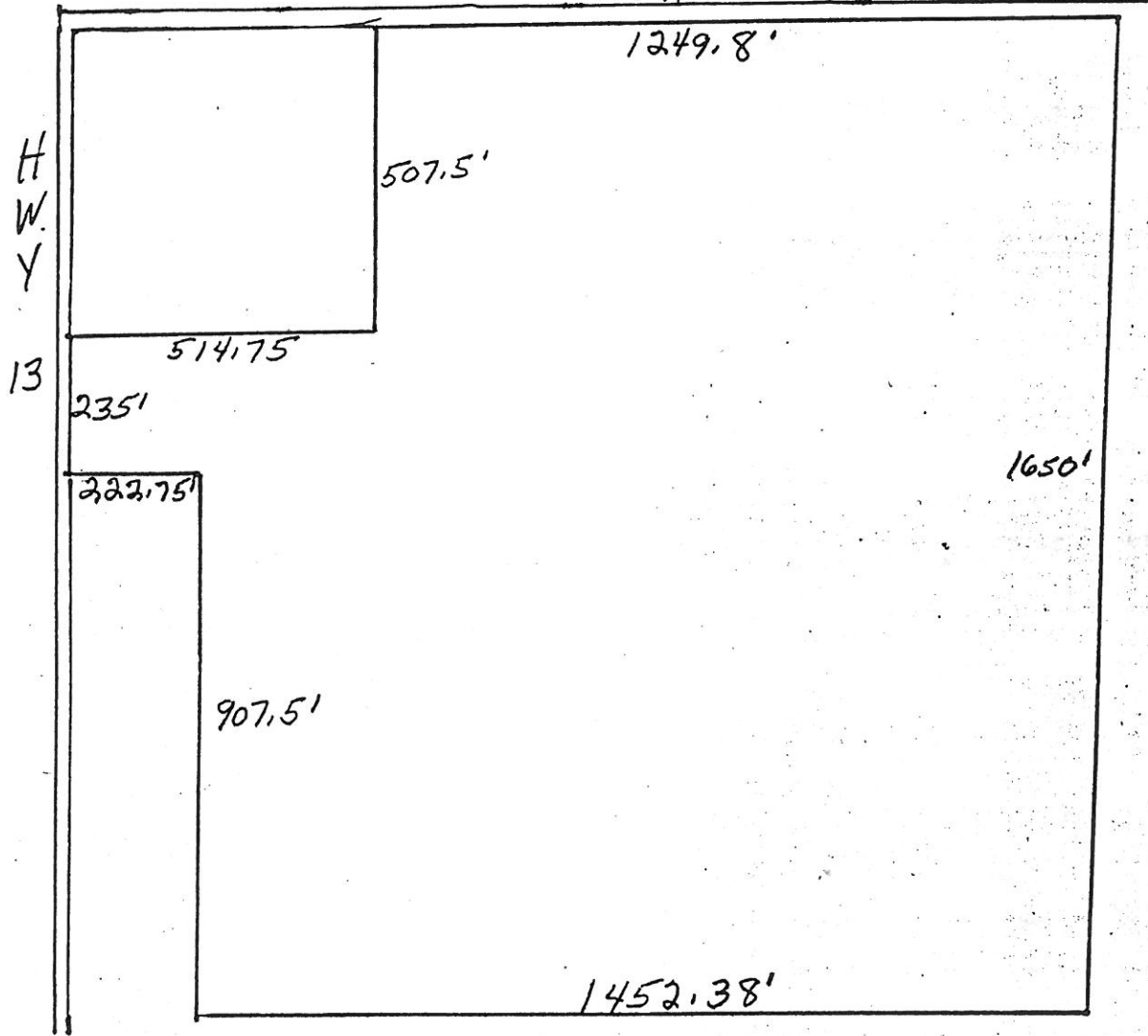
