

RESOLUTION NO. 207

Description of Street Right-of-Ways  
For  
"CINDY'S ESTATES" and "1<sup>ST</sup> ADDITION TO CINDY'S ESTATES"

A parcel of land located in the SW $\frac{1}{4}$ -SE $\frac{1}{4}$  of Section 12 Town 29 North, Range 1 East, Village of Dorchester, Clark County, Wisconsin, bounded by the following described line:

Commencing at the north one-quarter corner of said section 12; thence S01°58'40"W, 3,923.74 feet along the north-south  $\frac{1}{4}$  line of said section 12; thence N89°07'23"E, 25.94 feet to the east right-of-way of Liberty Street; thence S01°39'49"W, 95.09 feet, along said east right-of-way of Liberty Street, to the point of beginning;

Thence N89°07'23"E, 293.03; thence Southeasterly, 110.77 feet along the arc of a curve to the right, radius 230.00 feet and central angle of 27°35'39", the long chord of which bears S77°04'47.5"E, 109.70 feet; thence S63°16'58"E, 15.34 feet; thence Easterly, Southerly, and Westerly, 314.16 feet along the arc of a curve to the right, radius 60.00 feet and central angle of 300°00'00", the long chord of which bears S26°43'02"W, 60.00 feet; thence N63°16'58"W, 15.34 feet; thence Northwesterly, 81.87 feet along the arc of a curve to the left, radius 170.00 feet and central angle of 27°35'39" the long chord of which bears N77°04'47.5"W, 81.08 feet; thence S89°07'23"W, 12.36 feet; thence S01°58'40"W, 201.15 feet; thence S01°58'40"W, 230.06 feet; thence S02°43'00"W, 202.84 feet; thence S01°39'05"W, 189.45 feet; thence N88°20'31"W, 60.00 feet; thence N01°39'05"E, 190.00 feet; thence N88°20'44"W, 216.96 feet; thence N01°39'45"E, 60.00 feet; thence S88°20'44"E, 218.06 feet; thence N02°43'00"E, 143.00 feet; thence N01°58'40"E, 229.41 feet; thence N01°58'40"E, 198.42 feet; thence S89°07'23"W, 223.26 feet; thence N01°39'49"E, 60.06 feet to the point of beginning.
